

#### End User License Agreement/Order Form Supplement for BSM for Android

This is a legally binding agreement. Please read it carefully. By clicking "I Accept", or installing or using the BSM (as defined below) for Android software and/or any updates to such software provided by BSM (the **"Software"**), you:

- agree to the following terms on behalf of the BSM customer with which you are employed, affiliated or associated (the "**Customer**");
- represent that you have the authority to bind the Customer to these terms, and
- represent that you are an Authorized User under the master software subscription, professional services and hardware purchase agreement between BSM and the Customer (the "Master Agreement") available at <u>www.bsmtechnologies.com/company/legal/agreements</u>, and any successor websites.

If you do not have such authority, are not an Authorized User, or do not agree to these terms, you may not install or use the Software.

Google Inc. ("**Google**") may, at any time and without notice, restrict, interrupt or prevent use of the Software, or delete the Software from your or the Customer's device, or require BSM to do any of the foregoing, without entitling the Customer or you to any refund, credit or other compensation from BSM or any third party (including, but not limited to, Google or your network connectivity provider).

This End User License Agreement/Order Form Supplement was last updated on February 1, 2019. It is effective between the Customer and BSM as of the date you first download, install or use the Software, whichever is earliest.

#### 1. THIS END USER LICENSE AGREEMENT/ORDER FORM SUPPLEMENT

This End User License Agreement/Order Form Supplement is a part of each order form by which the Customer ordered the BSM service, or a BSM service incorporating the BSM for Android service (an "**Order Form**"). The Order Form and this End User License Agreement/Order Form Supplement are governed by the Master Agreement. This End User License Agreement/Order Form Supplement adjusts certain terms of the Master Agreement, solely with respect to the Software. Capitalized terms used but not defined in this End User License Agreement have the meanings given to them in the Master Agreement.

#### 2. THE SOFTWARE

The Software allows BSM customers to use the BSM service from Supported Devices. A "**Supported Device**" is a combination of a mobile device model running Android software and an Android software version(s) that is supported by the Software. The Software is provided by BSM as a component of the BSM service.

#### 3. WHO YOU ARE CONTRACTING WITH

This End User License Agreement/Order Form Supplement is being entered into between the BSM entity named on the Order Form (either BSM Technologies Ltd. or BSM Analytics Inc.) ("**BSM**") and the Customer. In this End User License Agreement/Order Form Supplement, the term "**BSM**" means that entity.

### 4. SOFTWARE LICENSE

The Software, including software embedded in the Software, is licensed, not sold, to the Customer by BSM only under the terms of the Master Agreement, the Order Form and this End User License Agreement/Order Form Supplement, and BSM reserves all rights not expressly granted to the Customer. This Software may include some third-party software; please see the Documentation for additional notices required by our licensors. The Customer or you own the media or device on which the Software is recorded or stored but BSM retains ownership of the Software itself.

## 5. PERMITTED LICENSE USES AND RESTRICTIONS

- (a) This End User License Agreement/Order Form Supplement allows you, as an Authorized User under the Master Agreement, to use the Software on any Supported Device and on no other devices.
- (b) You may not distribute or make the Software available over a network where it could be used by multiple devices at the same time.
- (c) With respect to updates to the Software that BSM may make available for download, this End User License Agreement/Order Form Supplement allows you to download such Software updates to update or restore the Software on any Supported Device.
- (d) Except as and only to the extent permitted by applicable law, or by licensing terms governing use of open-sourced components included with the Software, neither you nor any other Customer personnel may copy, decompile, reverse engineer, disassemble, attempt to derive the source code of, decrypt, modify, or create derivative works of the Software or Software updates, or any part thereof. Any attempt to do so is a violation of the rights of BSM and its licensors. If you or any other Customer personnel violate this restriction, you or they, and the Customer, may be subject to prosecution and damages.
- (e) Neither you nor the Customer may rent, lease, lend, redistribute or sublicense the Software. The Customer may, however, allow other authorized Users under the Master Agreement to use the Software in connection with a re-assignment of the Supported Device to another Authorized User under the Master Agreement.
- (f) The Software is available only for Supported Devices, and is not available for all devices. Please contact your BSM representative to determine whether a specific device-Android software combination is supported by the Software.
- (g) In addition to mobile applications offered by BSM (and for purposes of this section 5(g), "bsmtechnologies.com" shall include any Affiliates of BSM), BSM may offer platforms for the creation of third-party mobile applications, including but not limited to the BSM platform. Third parties may obtain information from, or access data stored on, Authorized Users' mobile devices to provide services associated with any third-party mobile applications that Authorized Users download, install, use, or otherwise interact with over a BSM platform. BSM's mobile applications may also contain links or integrations to other mobile applications provided by third parties. BSM is not responsible for the security and privacy of data collected through third-party mobile applications or the privacy and security practices of the foregoing third parties.
- (h) Without limiting the generality of anything herein, you acknowledge and agree that the Software may collect user or device data for the purposes of providing services or functions that are relevant to use of the Software.

## 6. PERMITTED LICENSE USES AND RESTRICTIONS

BSM may terminate this End User License Agreement/Order Form Supplement at any time upon 30 days' notice to Customer without cause, or immediately upon notice to the Customer if any third party (including, but not limited to, Google, or your network connectivity provider) restricts, prevents or ceases to authorize the installation or use of the Software on your Supported Device or over your network. In addition, this End User License Agreement/Order Form Supplement shall terminate immediately and automatically upon any termination or expiration of the Customer's subscription to the BSM service. Upon any such termination or expiration, the Customer (including you) shall no longer be permitted to use the Software, and shall delete or destroy all copies of the Software in its (including your) possession.

Termination or expiration of this End User License Agreement/Order Form Supplement shall not entitle the Customer to any refund, credit, or other compensation from BSM under the Master Agreement or any other agreement or from any third party.

# 7. SERVICE LEVEL AGREEMENT

Any service level agreement in effect between the Customer and BSM shall not apply to the Software.

## 8. TERMS REQUIRED BY GOOGLE

- (a) This End User License Agreement/Order Form Supplement constitutes an end user license agreement (EULA) in lieu of any license grant provided by Google to use the Software on a Supported Device. This End User License Agreement/Order Form Supplement is between the Customer and BSM only, and not with Google. BSM is solely responsible for the Software.
- (b) The Google Play marketplace is owned and operated by Google. Your use of Google Play is governed by a legal agreement between you and Google consisting of the Google Terms of Service (found at <u>http://www.google.com/accounts/TOS</u>) and the Google Play Terms of Service (found at <u>https://play.google.com/intl/en-US\_us/about/play-terms.html</u> and together with the Google Terms of Service called the "**Terms**"). In addition, your use of Google Play is subject to the Google Play Business and Program Policies (<u>https://play.google.com/about/developer-content-policy/#!?modal\_active=none</u>). The Terms shall take precedence in that order in the event of a conflict between them, to the extent of such conflict.
- (c) BSM is solely responsible for providing, and Google has no obligation to provide, maintenance and support for the Software. Support requests, as well as questions, complaints or claims regarding the Software, may be directed to BSM Customer Support.
- (d) To the maximum extent permitted by applicable law, Google will have no warranty obligation whatsoever with respect to the Software, and will not be liable for any claims, losses, liabilities, damages, costs or expenses attributable to any failure to conform to any warranty. BSM shall not be required to provide a refund to you or to the Customer under any circumstances.
- (e) Google shall not be responsible for addressing any claims by you, the Customer or any third party relating to the Software or your or the Customer's possession and/or use of the Software, including but not limited to (i) product liability claims, (ii) any claim that the Software fails to conform to any applicable legal or regulatory requirement, or (iii) claims arising under consumer protection or similar legislation.
- (f) Google shall not be responsible for the investigation, defense, settlement or discharge of any claim that the Software or your or the Customer's possession and use of the Software infringes a third party's intellectual property rights.
- (g) The Customer or you represent and warrant that (i) the Software will not be downloaded or used in, or transported to, a country that is subject to a U.S. Government or Canadian Government embargo or has been designated by the U.S. Government as a "terrorist-supporting" country, and (ii) neither you, the Customer nor any Authorized User is listed on any U.S. Government or Canadian Government list of prohibited or restricted parties.
- (h) BSM's corporate address is 75 International Blvd., Suite 100, Toronto, Ontario M9W 6L9, Canada.
- (i) Notwithstanding anything to the contrary in the Master Agreement, Google and its subsidiaries are third-party beneficiaries of this End User License Agreement/Order Form Supplement, and have the right (and shall be deemed to have accepted the right) to enforce this End User License Agreement/Order Form Supplement against you and the Customer.
- (j) In order to continually innovate and improve Google Play, Google may collect certain usage statistics from Google Play and Supported Devices, including but not limited to, information on how Google Play and Supported Devices are being used. The data collected is examined in the aggregate to improve Google Play for users and developers and is maintained in accordance with Google's Privacy Policy. To ensure the improvement of the Software, limited aggregate data may be available to salesforce.com upon its written request.

### 9. MISCELLANEOUS

Subject to third-party terms to which BSM may be subject, you understand and agree that the functionality of the Software may in some circumstances include the sending of push notifications to you on your Supported Device that are related to the operation of the Software, the underlying services, or other communications about BSM.
